So to paraphrase, zoning will not get involved, but if there are situations where parking or noise are an issue, the only municipal participation will come from the police (parking) or code enforcement (noise).

The law is the law. To be specific as far as case law 'the standard of 25 was derived from the Farhi v. Commissioners of the Borough of Deal case, in that case the homeowner had a regular congregation of 15-25 congregants in his home on the Sabbath and other Holy Days. The court held that "the guarantee of freedom of worship as set forth by our State Constitution forecloses any use by a municipal authority of its zoning power to prohibit the free exercise of religious activity in the privacy of one's home." The Court stated that any concerns about noise, traffic and crowding could be addressed adequately by the police power dealing with parking, noise or health and not through zoning.'

As far as a corporation owned rental. This is still a residential rental and as such there is a maximum amount of people that can live full time based upon square footage. That does not prohibit you from having a large gathering or having more people spend the night 'occasionally'.

I would suggest a meeting for any further questions so this can be adequately answered and understood. There seems to be misunderstandings based upon language and many assumptions being made.

Ms. Cusanelli:

With your updated description location I was unable to locate this by driving on New Prospect. As a result I walked the entire walkway along Harmony Farms and I was able to locate one property (#95 Hickory Hill which backs to New Prospect)) that had a pole installed at each corner of their rear property connected by a wire (photo attached). Without an official survey/engineer report it would appear that each pole is on the designated private property. This conclusion is based on the fact that the poles align with fence posts to an adjoining property and unless those fences were installed improperly, which does not appear to be the case, this is the private property of #95 Hickory Hill Road. This area joins up with Harmony Farms HOA property which is where the walkway is. In any event this is not 'public property' but at worse case scenario belongs to the Harmony Farms HOA, which becomes an issue between those parties. These poles/wires do not present any safety concerns as they are currently set. The poles are not easily visible from New Prospect, even with looking for them, without foliage and certainly can not be seen when foliage blooms so there is no eyesore issue with or without the foliage. Based upon my inspection I find no violation with regards to this issue in this case.
